<u>Tender Notice for Annual maintenance of EPABX System and its allied works in Indian Institute of Geomagnetism New Panvel.</u>

Terms & conditions

- 1. The rates shall be quoted for the comprehensive maintenance of the EPABX system including repair maintenance of all extension lines, repairs of telephone instruments and deployment of technical person for prompt attendance of any faults in the system and its immediate rectification.
- 2. The AMC of EPABX system (Indian Institute of Geomagnetism New Panvel) that includes maintenance of the system including its repairs and maintenance of all extension lines at IIG New Panvel and deployment of technical person for prompt attendance of any fault in the system and its immediate rectifications. (PRA Line 01 nos, Analog Trunk Lines 16 nos, Digital Lines/Cards 16 nos, Analog Extensions 300 nos, Call Billing Software 01 no, Operator Console 300 with key phone Models, Digital Phones 12 nos, IPX 500 DC power supply card 02 nos, IPX 500 Tadiran CPU card 01 no, IP Phone Modes T207-10 Nos).
- 3. The rates tendered by the bidder/ firm shall be inclusive of GST. No increase on any account would be accepted by this office.
- 4. The bidder should have their registered office or branch in Navi Mumbai.
- 5. The bidder/firm should be registered with GST authorities and must be in possession of PAN. The documentary proof in this regard should be attached along with the bid.
- 6. The firm should have previous experience of at least five years in maintenance of EPABX system. Copies of experience are to be enclosed along with the bid.
- 7. Conditional tenders shall not be accepted.
- 8. Corrective maintenance will be carried as and when the complaints are registered with the firm in writing or on phone. The faults should be rectified by the same day or on the next day of the date of complaints.
- 9. Any breakdown in the system should be rectified within 24 hours of registering the complaint. In case of failure to rectify the complaint within 24 hours, an amount of Rs. 500/- will be deducted per day from the AMC bill payable to the firm.
- 10. All the items related to EPABX replaced will be of standard quality with ISI/BIS mark.

- 11. The faulty items once replaced, the same should be handed over to the office by the firm.
- 12. The technical person (s) must have an identity card and must wear it while on duty in this office. The identity card must be visible to make it easy to identify the technical person.
- 13. The technical person shall make his entry in the entry register kept by Security Post Receptionist.
- 14. The bidders are advised to visit the office during any working days to check the EPABX system and line layout.
- 15. The bid not complying with the conditions prescribed above will be summarily rejected.
- 16. The contract period shall initially be for one year only after the execution of the agreement of the contract. The contract may be renewed for further two years, one year at a time, at the discretion of this office based on satisfactory services provided by the agency on the same terms and conditions.
- 17. The successful bidder shall be required to furnish a performance security of Rs. 25,000/- (Rupees twenty five thousand only) through FDR in favor Indian Institute of Geomagnetism.
- 18. The performance security shall remain valid for a period of sixty days beyond the completion of all contractual obligations.
- 19. The office reserves the right to accept or reject any tender/all tenders in full or in part without assigning any reason whatsoever.
- 20. All disputes and differences arising out of/or in connection with this order shall be subject to the exclusive jurisdiction of courts in New Panvel.
