IIG, New Panvel, Navi Mumbai is not obliged to meet and have discussions with any vendor and / or to entertain any representations

7. Clarification of Bids

To assist the scrutiny, evaluation and comparison of bids, IIG, New Panvel, Navi Mumbai may, at its discretion, ask some or all vendors for clarification on the bids submitted by them. The request for such clarifications and the vendor response shall necessarily be in writing only.

8. **Preliminary Scrutiny**

Bids not meeting the qualification criteria will be rejected.

IIG , New Panvel, Navi Mumbai will scrutinize the bids received to determine whether they are complete and as per the tender requirement, whether technical documentation as asked for and required to evaluate the bid has been submitted, whether the documents have been properly signed, and whether items are bided as per the tender requirements.

17 Commercial bid validity

18. Fixed Price

19. Payment terms

Payment will be made on supply of material, installation and successful commissioning of the systems and submission of Performance Bank Guarantee.

20. Support capability in India

Vendor should provide information regarding their after sales support infrastructure in India such as office address and contact details.

21. Force Majeure

The vendor shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that it's delay in performance or other failure to perform its obligations under the contract is the result of an event of force Majeure. For purposes of this Clause, "Force Majeure" means an event beyond the control of the Vendor and not involving the vendor's fault or negligence and not foreseeable. Such events may include, but are not limited to, Acts of God or of public enemy, acts of Government of India in their sovereign capacity, acts of war, and acts of IIG either in fires, floods, strikes, lock-outs and freight embargoes.

If a Force Majeure situation arises, the Vendor shall promptly notify IIG in writing of such conditions and the cause thereof immediately. - 1. Prices should include transportation, installation, and maintenance for 2 years, including all manufacturing flaws.
- Maximum educational discount.
- Quoted price should be in Indian Rupees only.
- 4. The laboratory fume hoods must confirm to the following regulations and standards.
 ASHRAE 110-2016, American Society of Heating, Refrigerating, and Air-Conditioning Engineers, Method of Testing Performance of Laboratory Fume Hoods.
- 5. At least 2 Customer feedback forms stating the quality of work and overall feedback of Project Values of at least 20 Lacs.
- Bidder/ parent company has to submit: A). Test Report: Furniture to be type tested as per SEFA-8 standard by a third-party. B). Test Report: Fume Hood to be type-tested as per ASHRAE 110 by a third-party.
- 7. Additional Certificate: **ISO 9001: 2015; ISO 14001:2015; ISO 45001:2018** certification should also be submitted by the bidder/parent company.
- 8. The bidder or its parent company in India or abroad should have a well-established (their own) in house manufacturing unit for the steel lab furniture and fume hood, quality management system as per International standards providing the products and services on the continuous basis at least for the last 7 years. 2. Manufacturer's Authorization form

3. Warranty

The Supplier further warrants that the Goods shall be free from defects arising from any act or omission of the Supplier or arising from design, materials, and workmanship, under normal use in the conditions prevailing in India.

6. Performance Bank Guarantee

7. Spare parts

The vendor will make the parts for the systems available for a further period of two years on completion of warranty period. If any of the peripherals / components is not available during/after the warranty period, the substitution shall be carried out with peripherals/components of equivalent or higher capacity.

8. Indemnity




